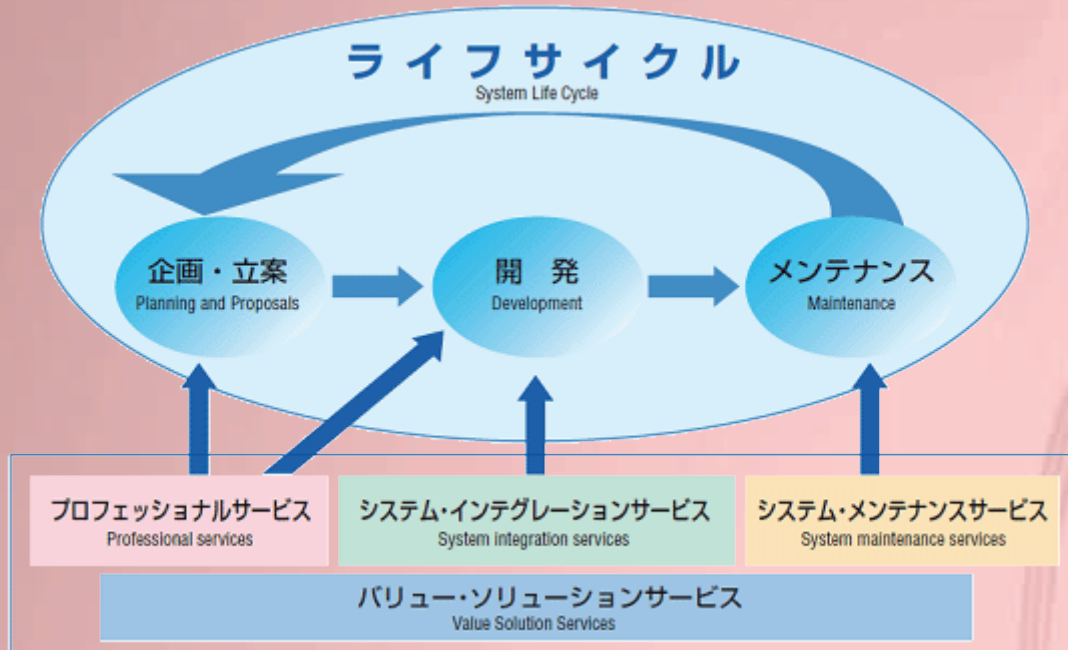

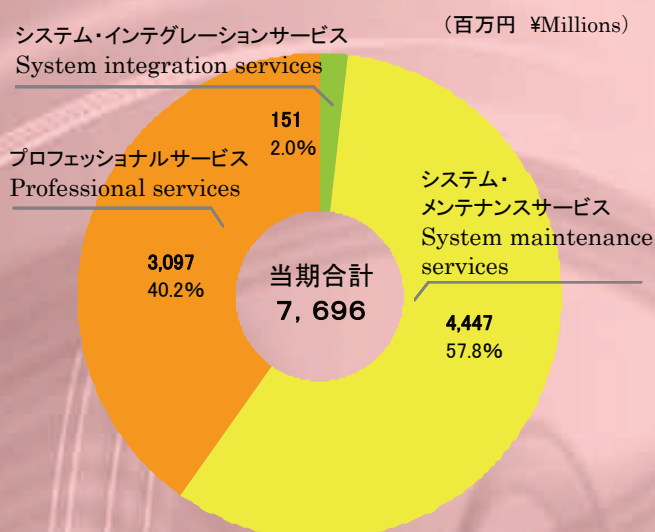

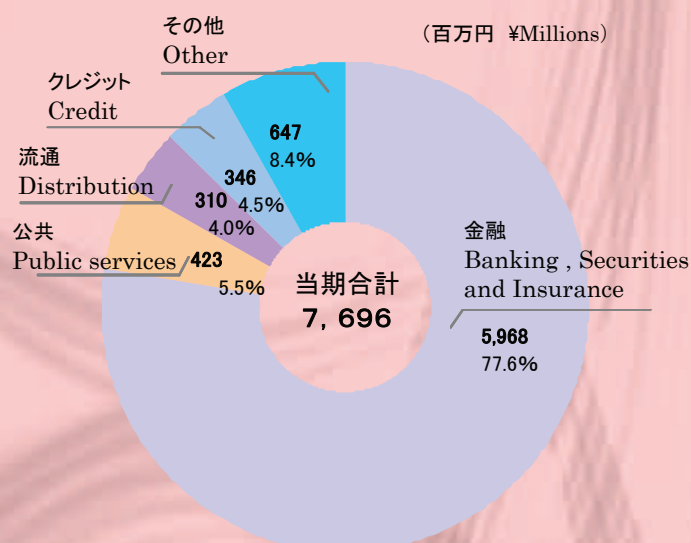

Sales by service segment



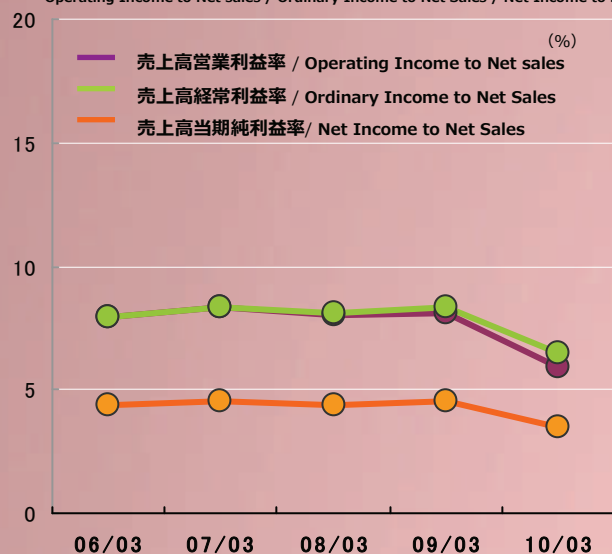
ユーザーの業種別売上高／構成比率

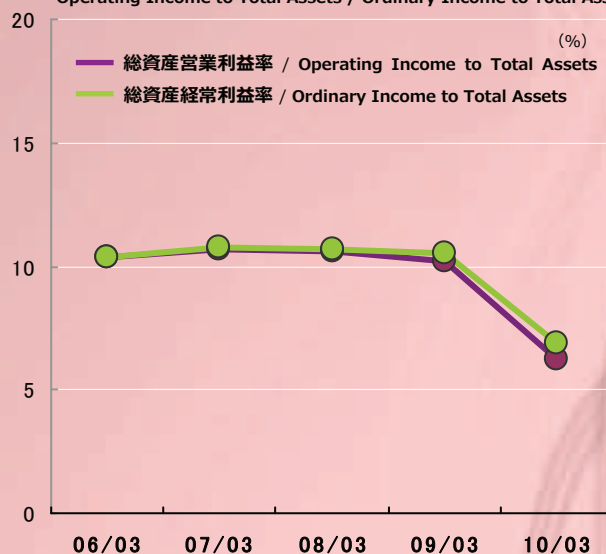

Operating Income to Net sales / Ordinary Income to Net Sales / Net Income to Net Sales



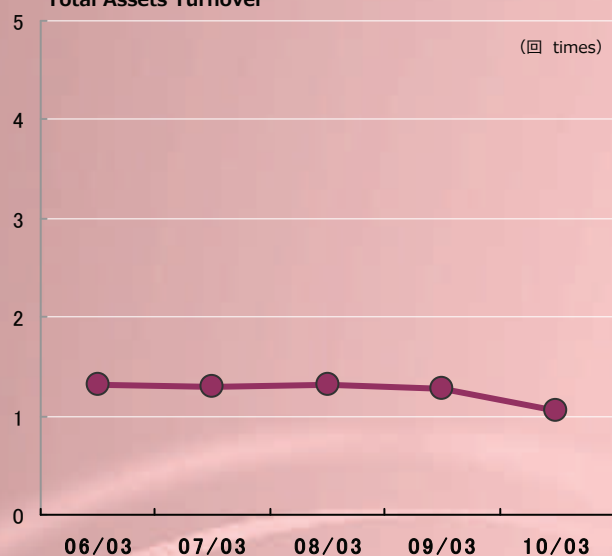
総資産営業利益率 / 総資産経常利益率

Operating Income to Total Assets / Ordinary Income to Total Assets



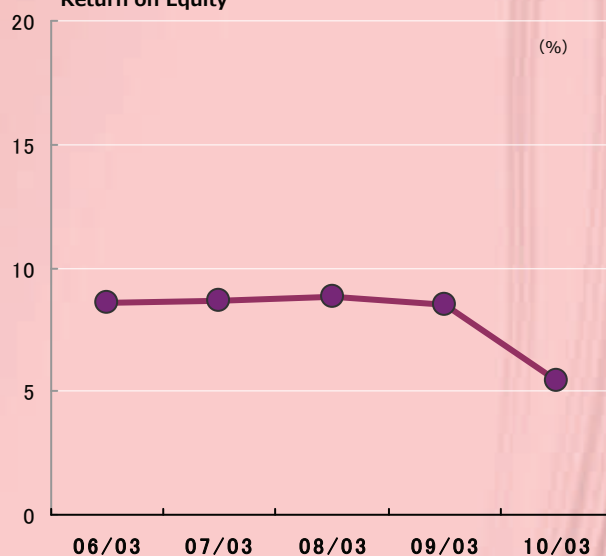
総資産回転率

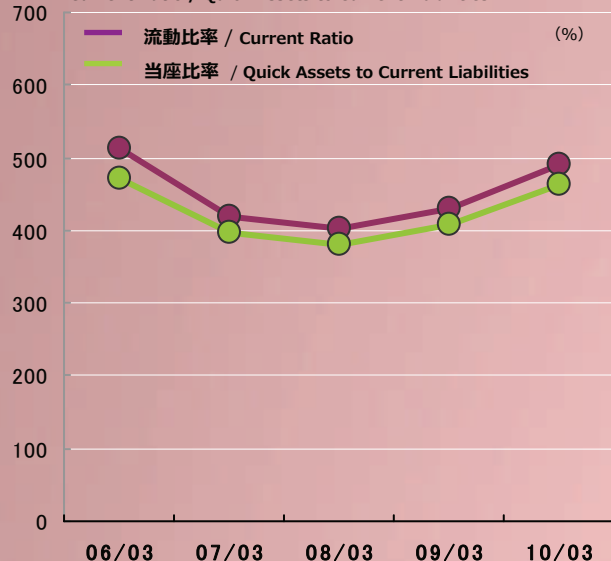

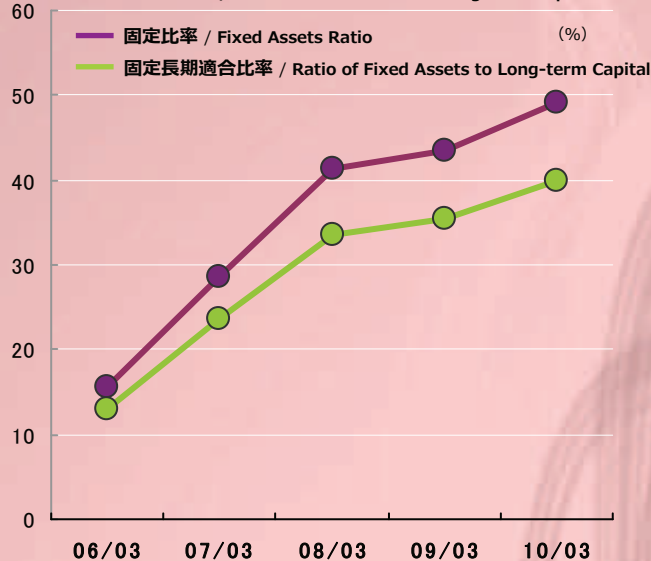

Current Ratio / Quick Assets to Current Liabilities



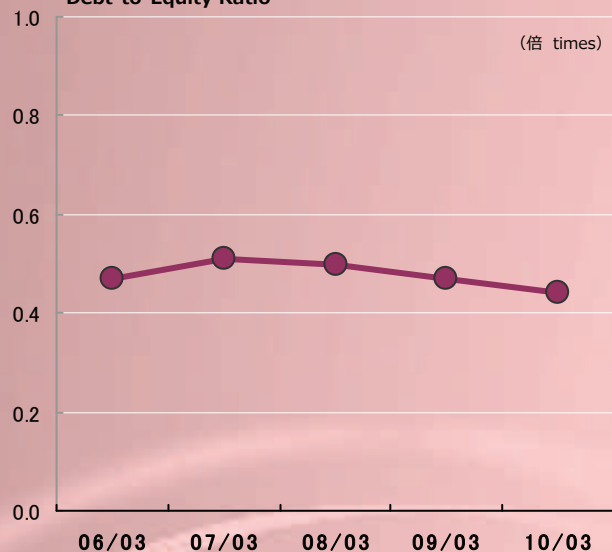

Fixed Assets Ratio / Ratio of Fixed Assets to Long-term Capital



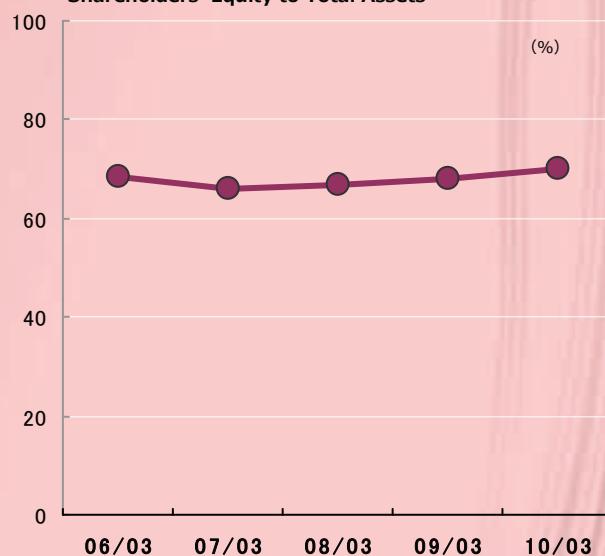

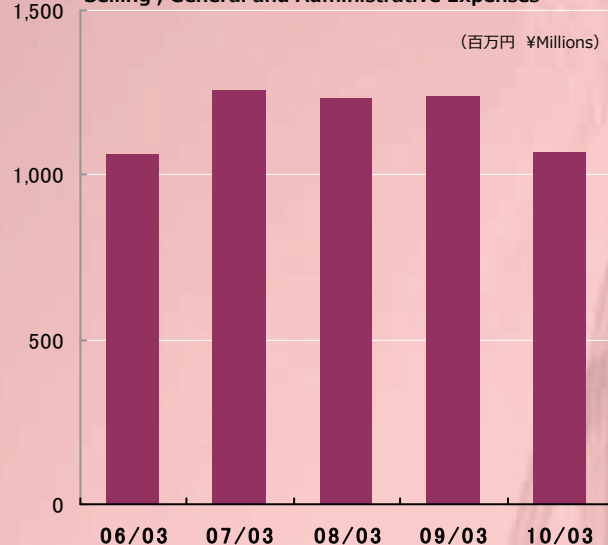
設備投資 / 減価償却費

Capital Expenditures / Depreciation Expenses



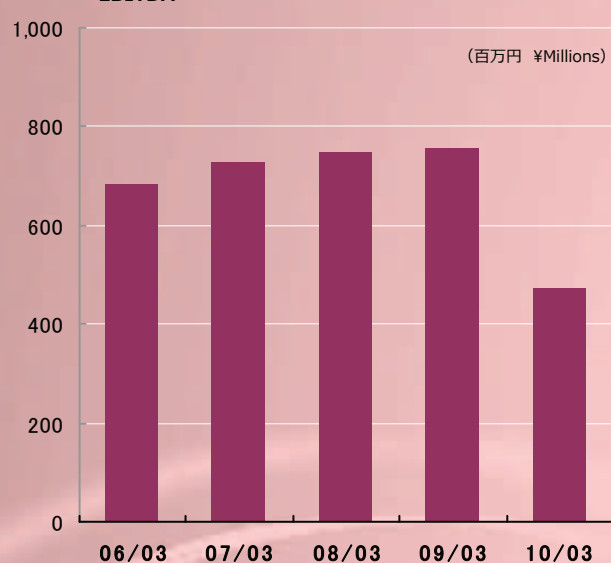

Selling, General and Administrative Expenses



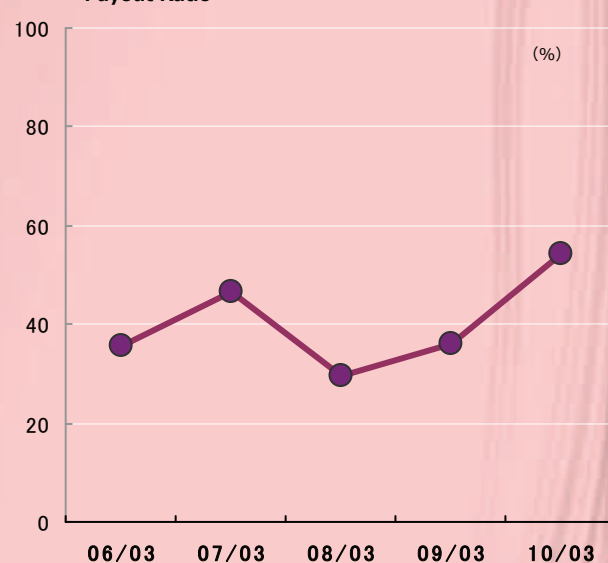
