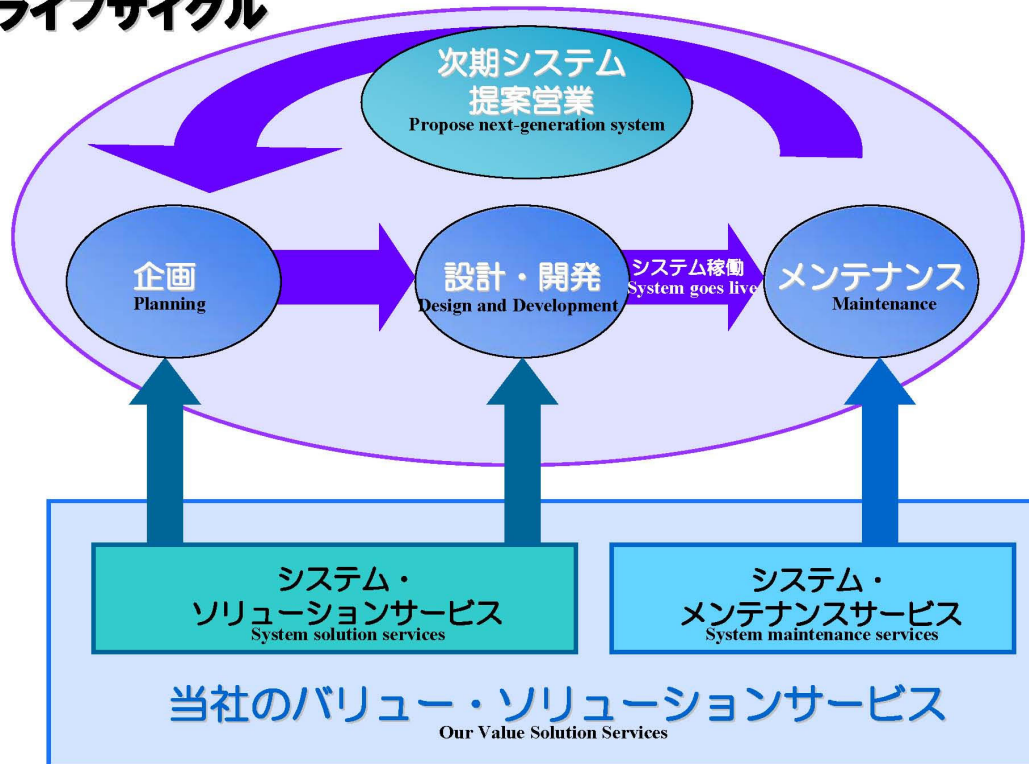

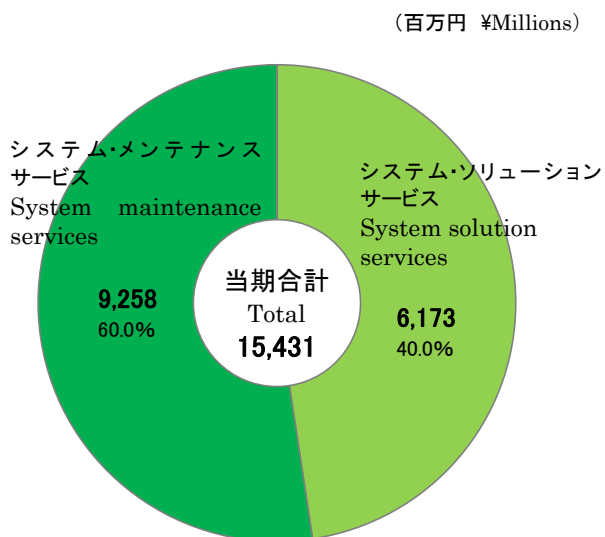

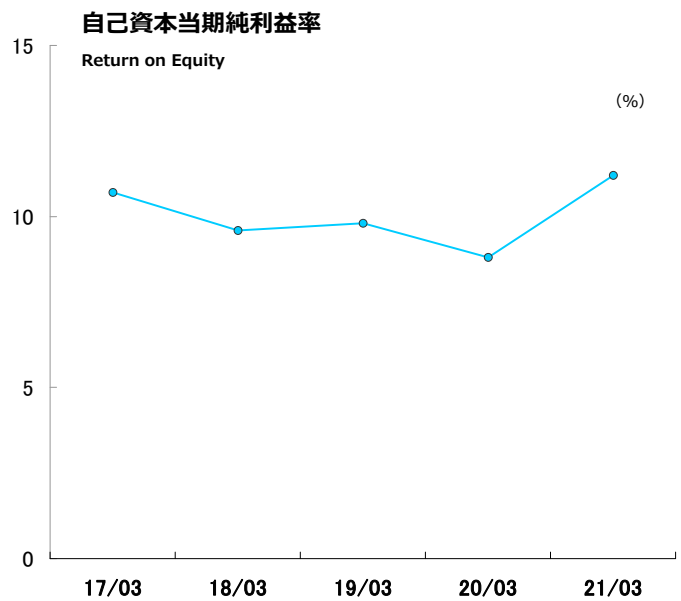
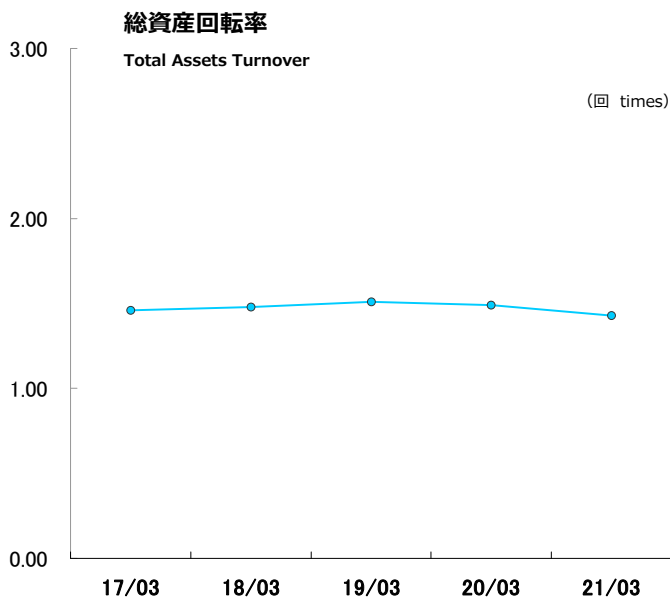
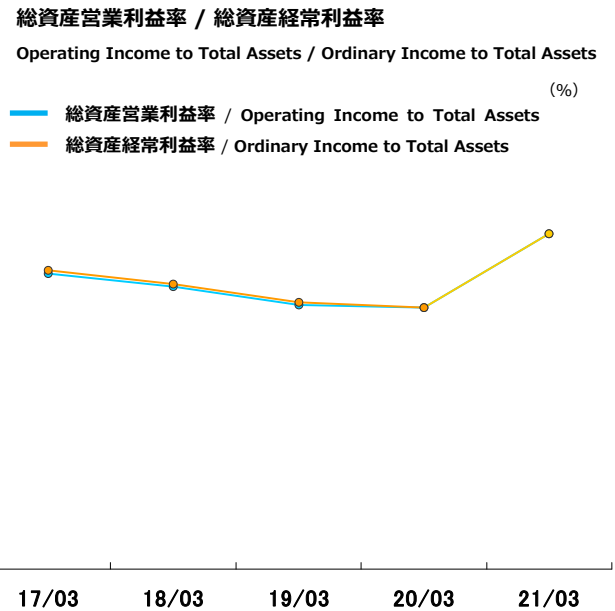
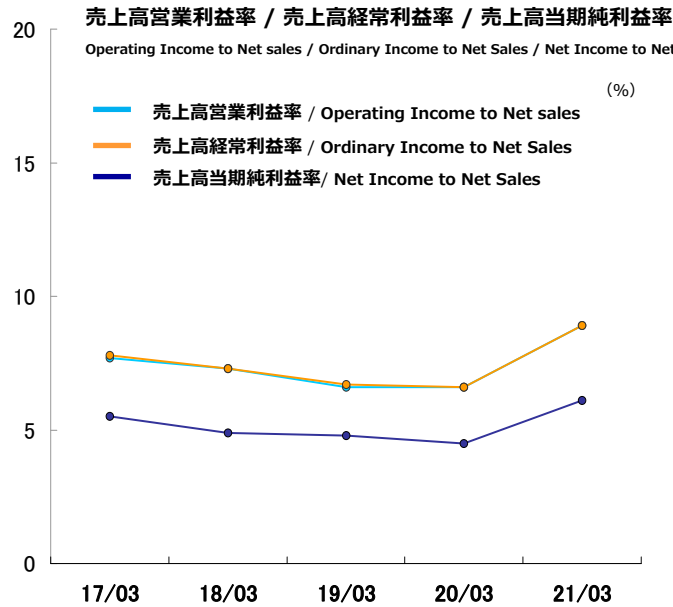
サービス分野別売上高／構成比率

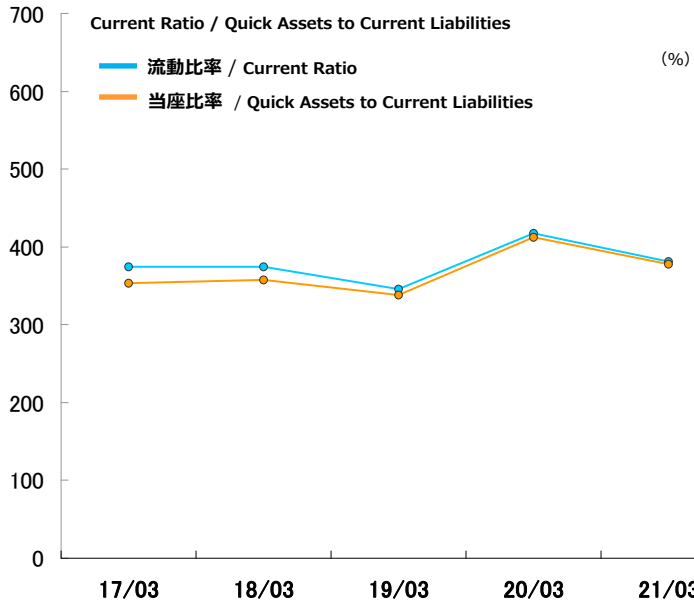

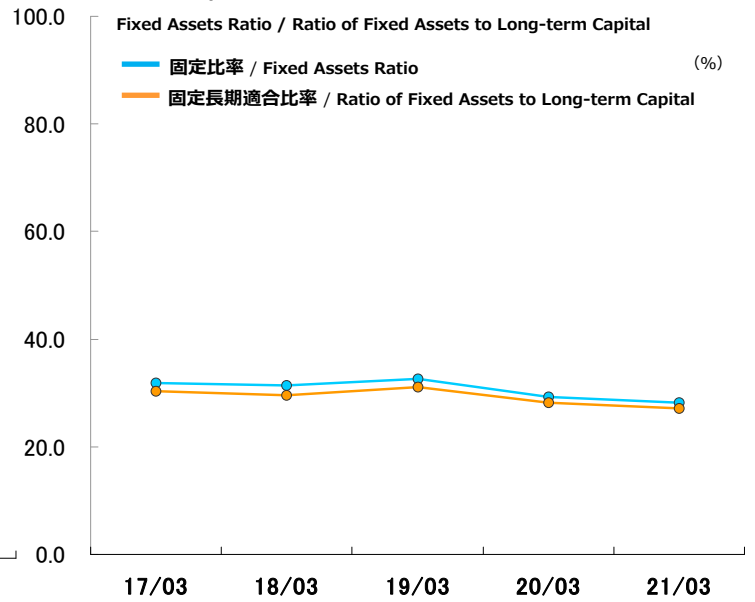

Current Ratio / Quick Assets to Current Liabilities



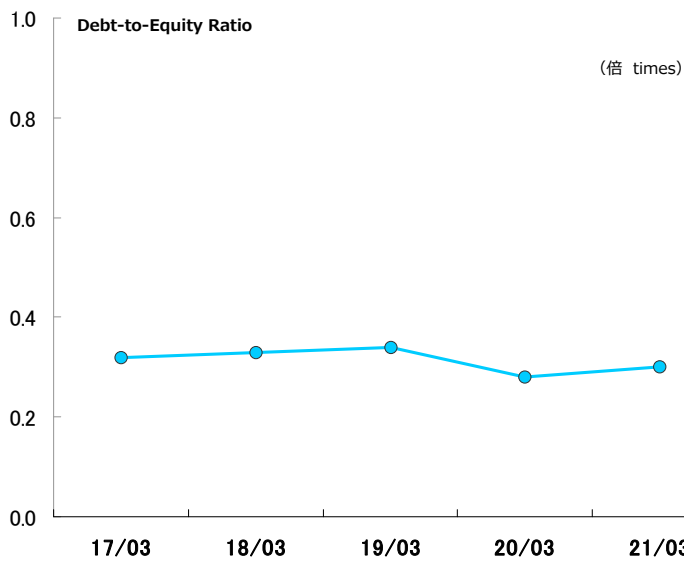

Fixed Assets Ratio / Ratio of Fixed Assets to Long-term Capital



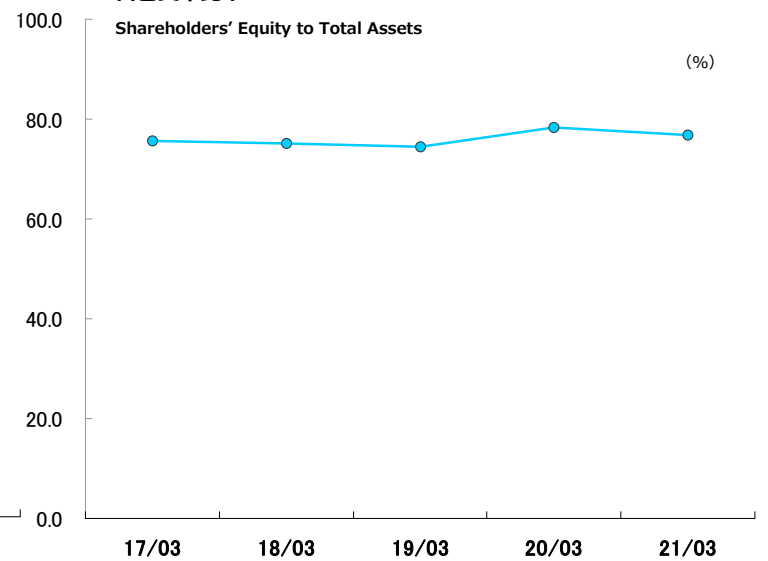

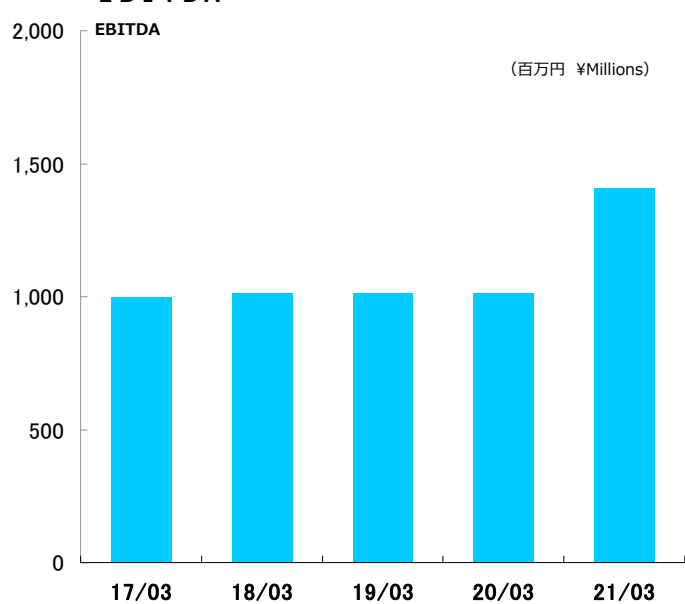
設備投資 / 減価償却費



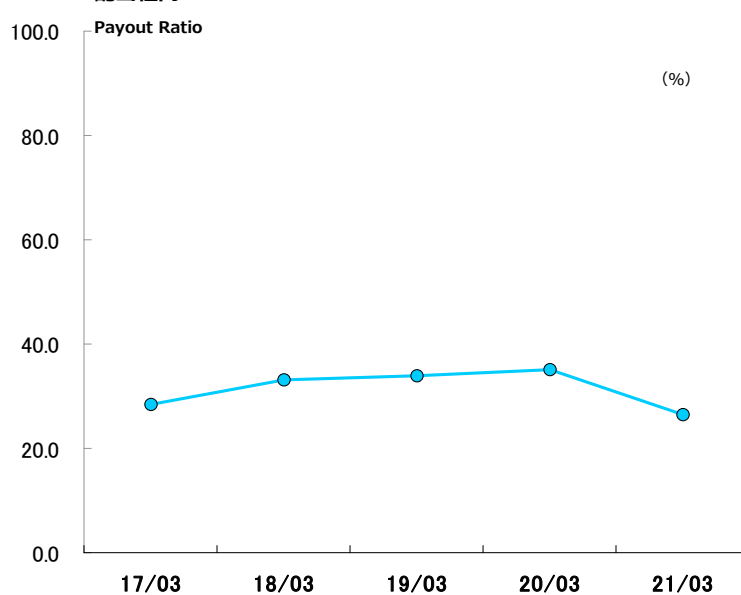
