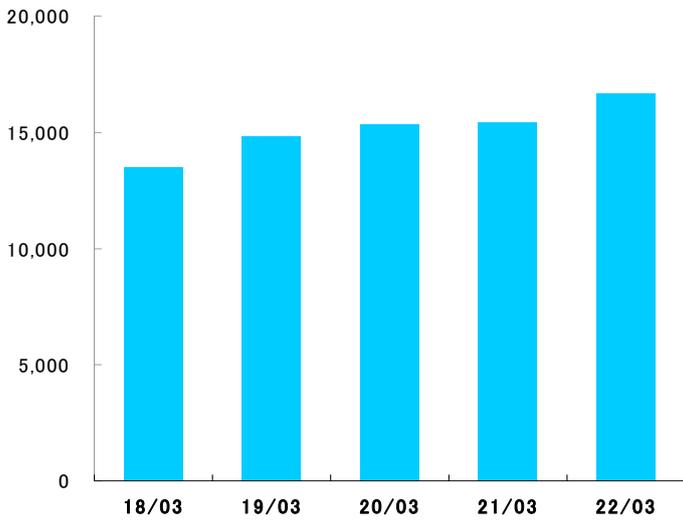

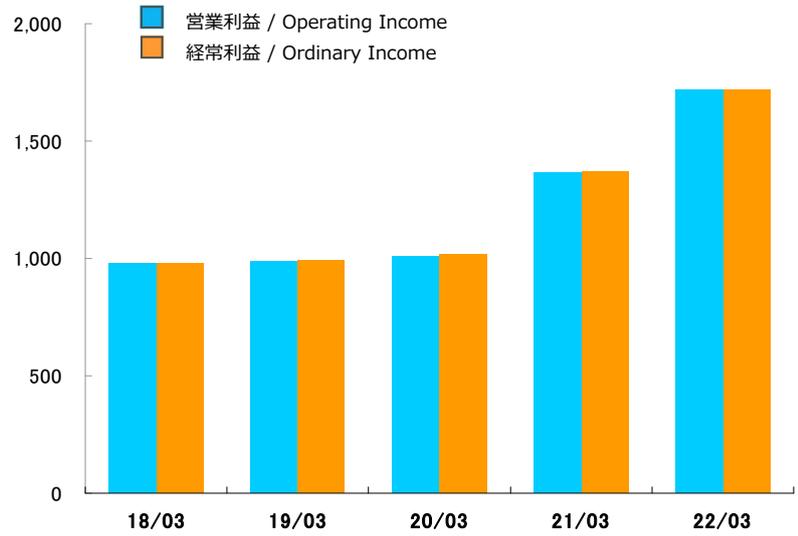

**営業利益/経常利益**

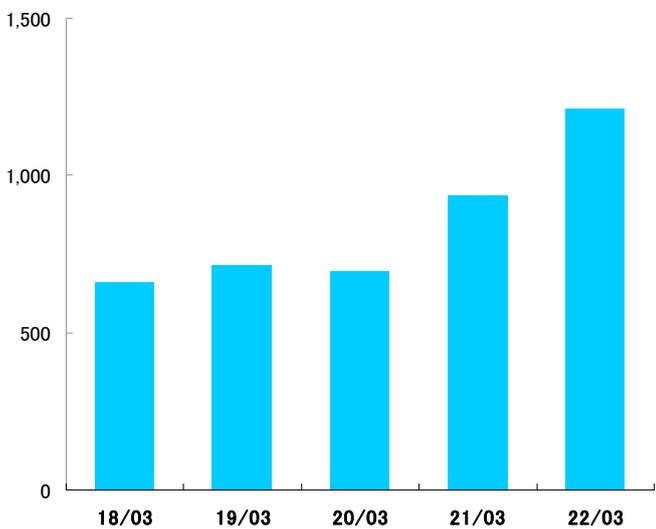
Operating Income / Ordinary Income

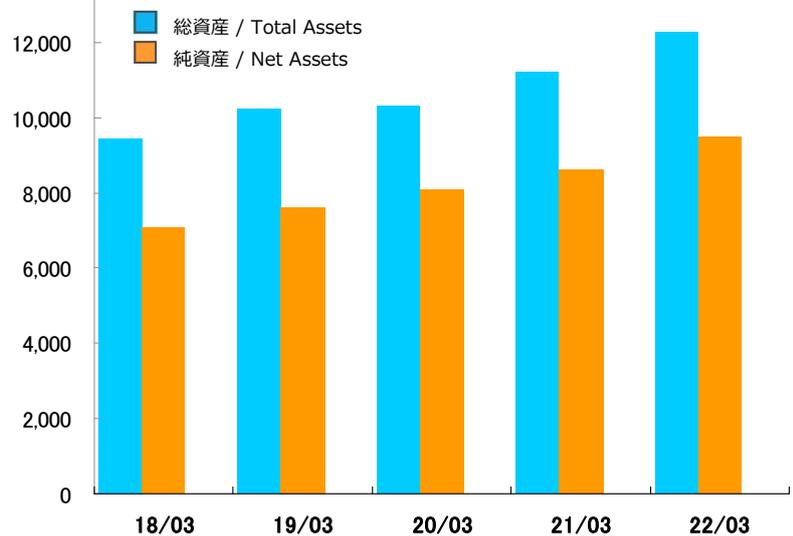

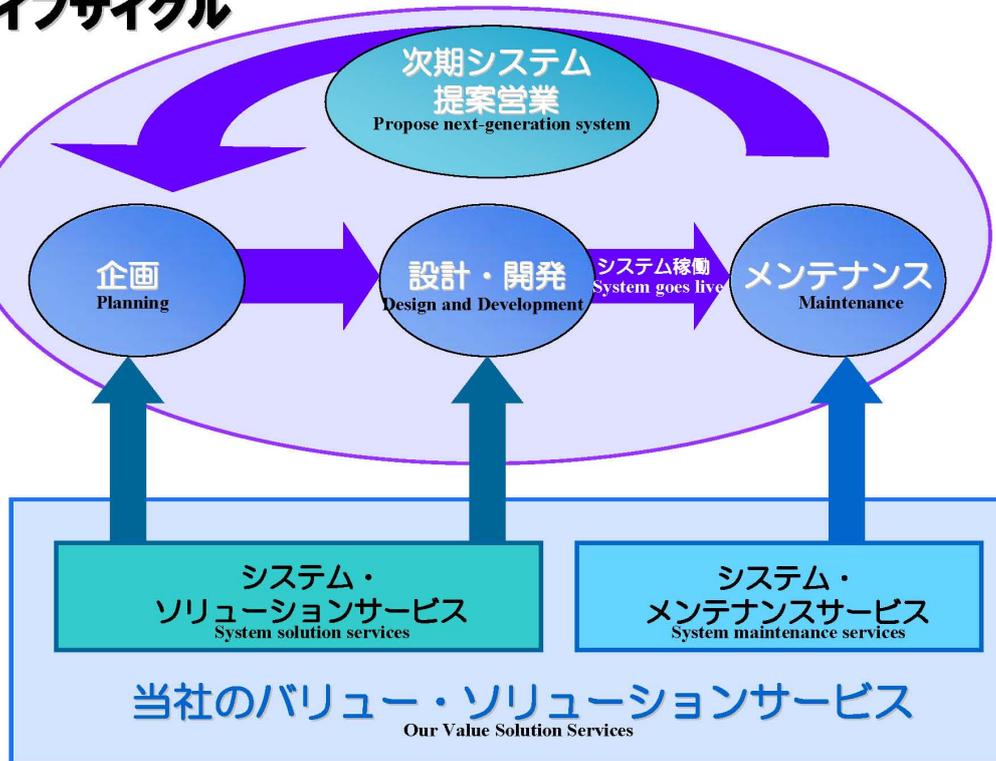

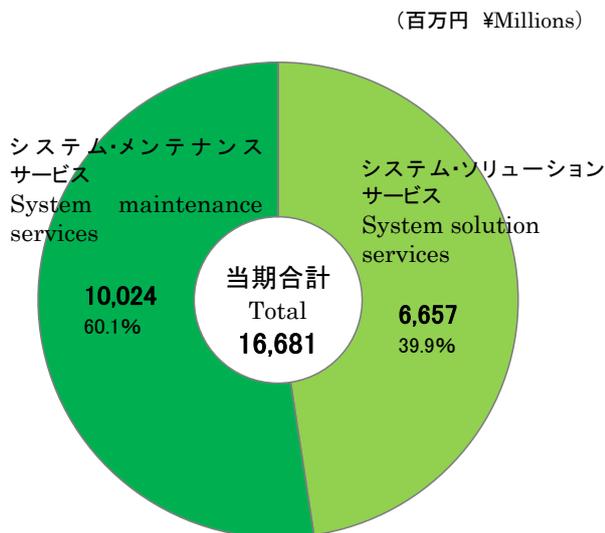

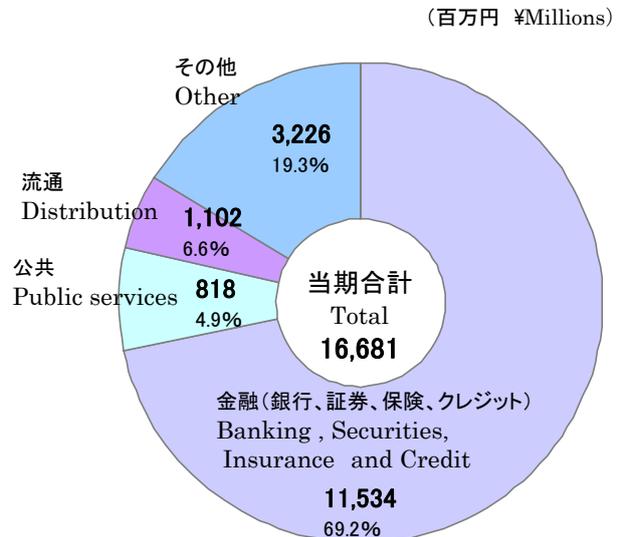

Sales and Ratio by service segment



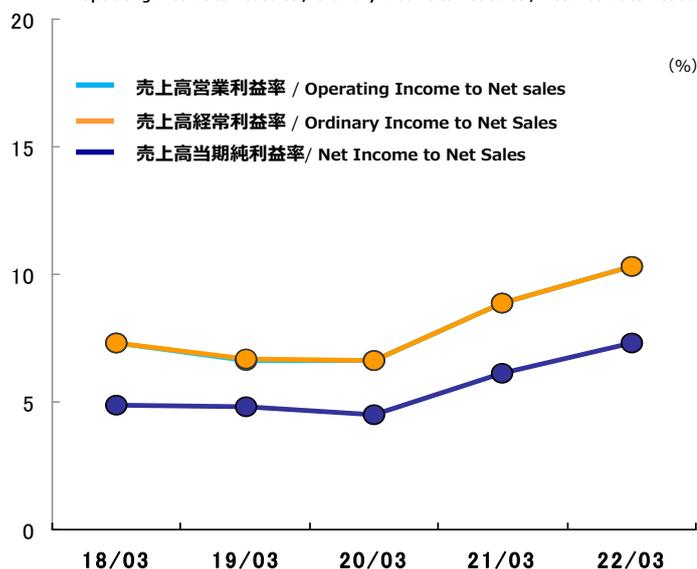
ユーザーの業種別売上高／構成比率

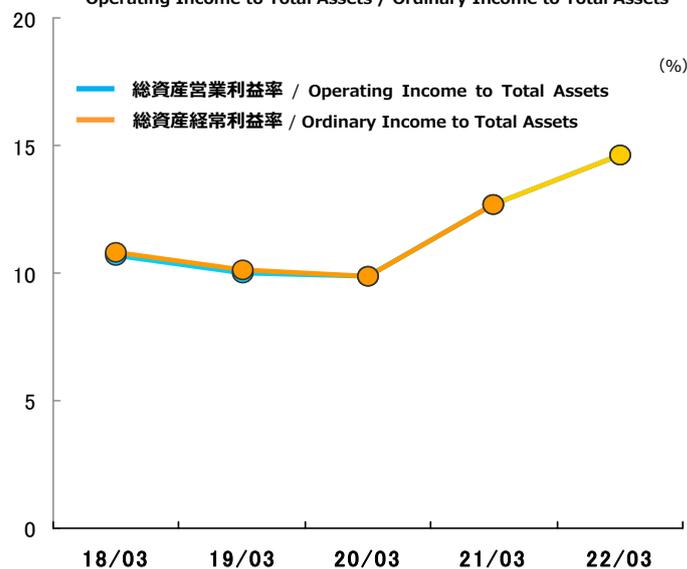

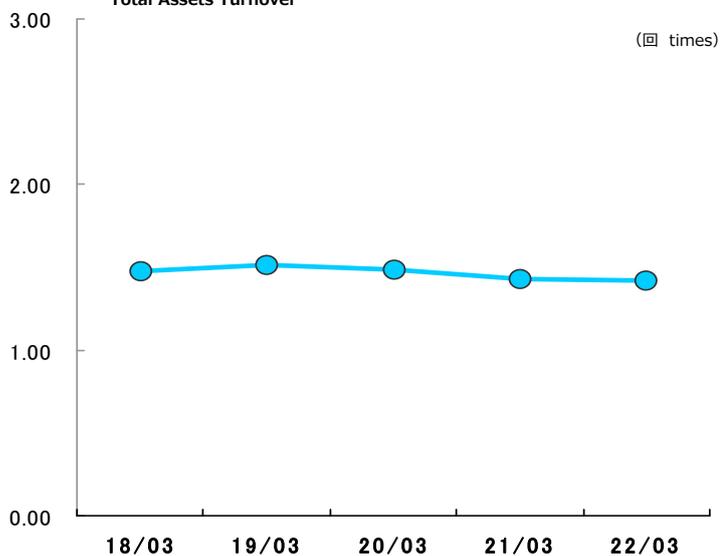

Operating Income to Total Assets / Ordinary Income to Total Assets



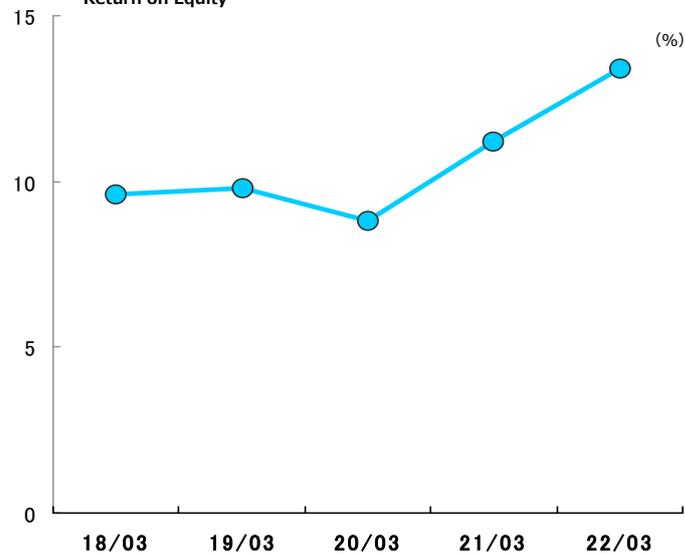

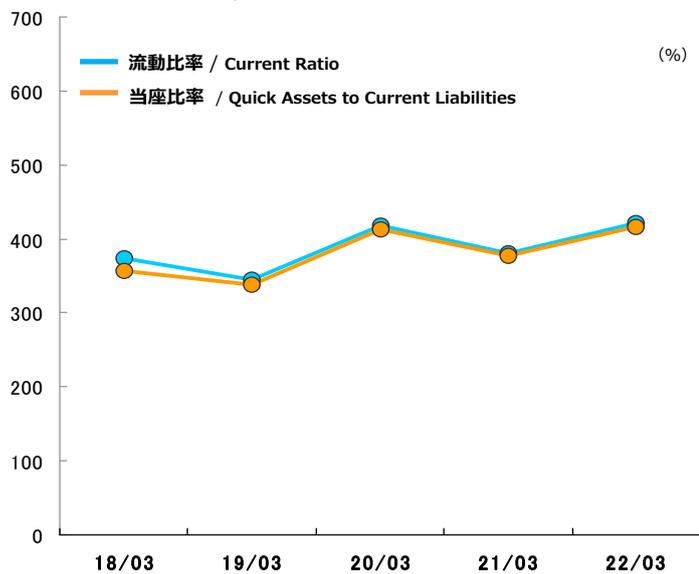

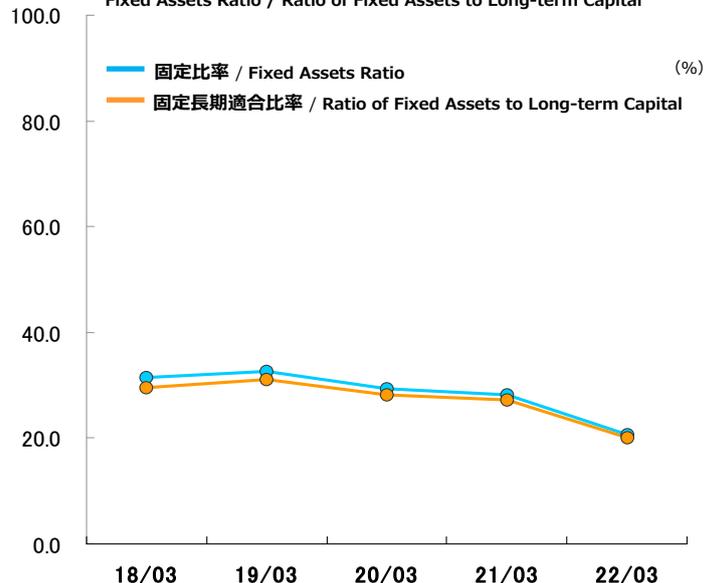

Current Ratio / Quick Assets to Current Liabilities



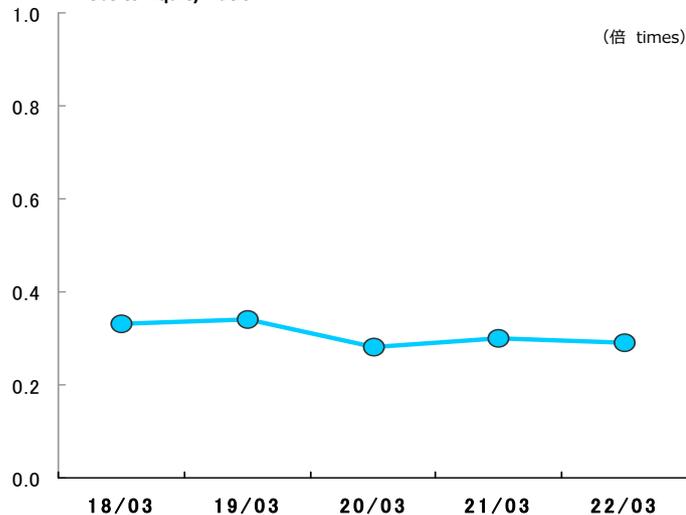

Fixed Assets Ratio / Ratio of Fixed Assets to Long-term Capital



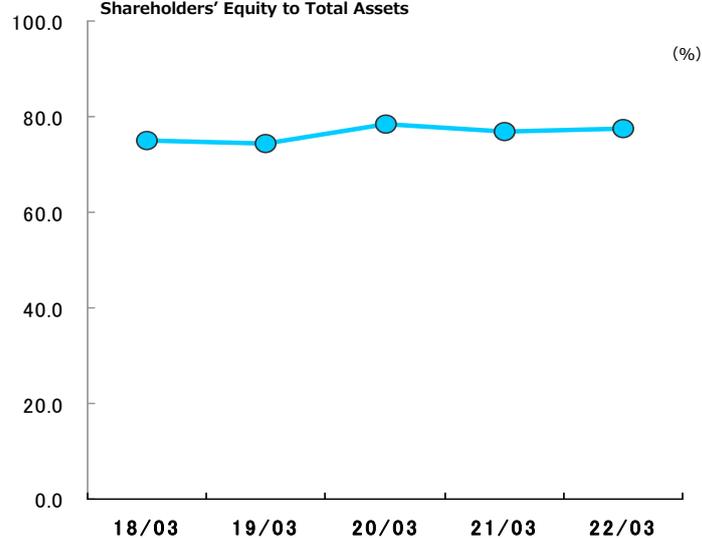

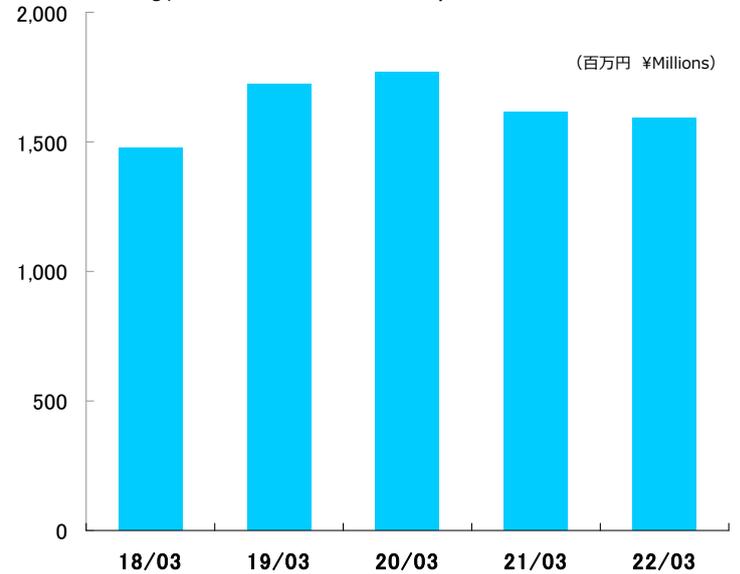
## 設備投資 / 減価償却費

Capital Expenditures / Depreciation



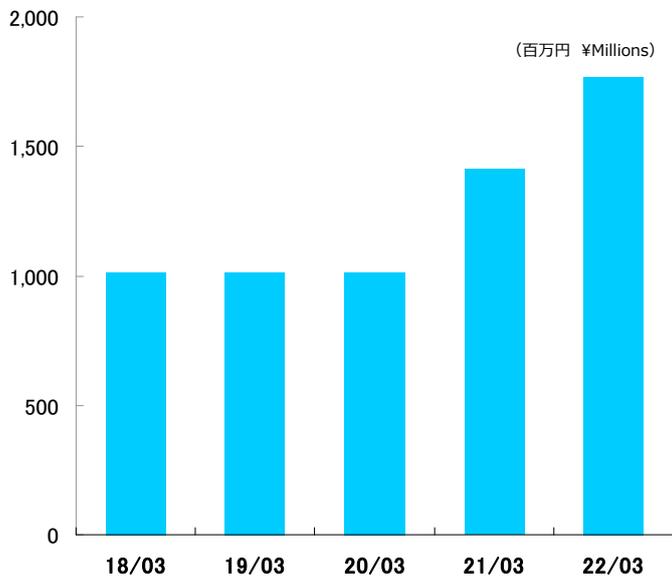

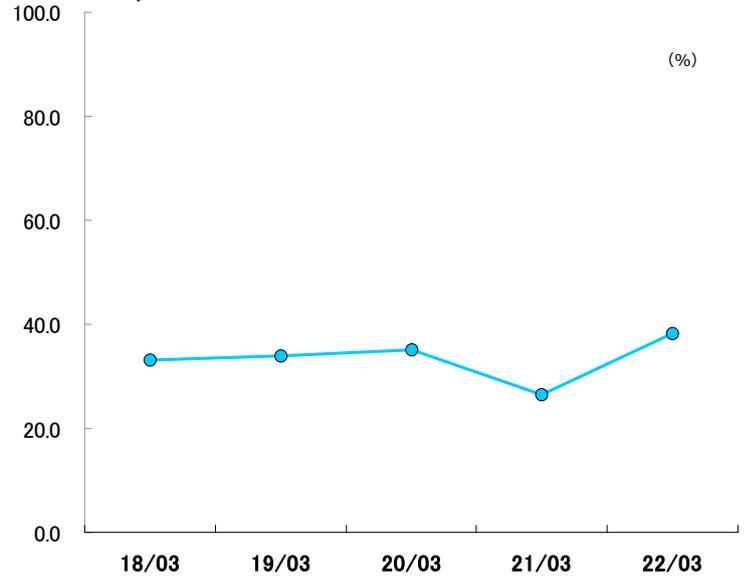
